

Salt Rock Holiday Booking Terms & Conditions

NO ADULT GROUPS, MUST HAVE CHILDREN unless owner approval given
NO FUNCTIONS unless owner approval given

Strictly no parties, and no student / scholar groups accepted

No pets allowed

No smoking inside the house

Check in: strictly after 2pm

Check out: strictly before 9am otherwise the deposit will not be refunded

Please note that you are responsible for all your own toiletries. If your stay is longer than 2 days, you will need to bring your own toilet paper and washing powder.

Bed linen and bath towels are provided, but you are required to bring your own swimming towels.

DSTV is included in your stay

Maximum occupancy 12 people including children

We have a house-keeper who lives on the property and cares for the house and the guests who stay. Her name is Nomusa and she is kind, helpful and courteous. We ask that you reciprocate.

She is available from 8am to 5pm daily (except for Saturdays where she works until 12pm, and Sundays & Public holidays until 10am). She does not work on Christmas day.

She will clean the house, make the beds as well as washing and ironing. We ask that you pay her between R100-R150 daily for her duties.

Please note a minimum of a 2-night stay is required, or 7 nights over peak period (15 December – 15 January).

Salt Rock cancellation policy

Cancellation 14 days or less prior to arrival – full payment due

Cancellation 15-28 days prior to arrival – 50% payable

Cancellation 28 days or more prior to arrival – R250 handling fee

*** R2000 breakage deposit is required on every booking and will be refunded after your stay, should there be no damages. R5000 for adult only booking.

Rates are subject to change without notice. Any cash or cheque deposits will be at the cost of the visitor and not Salt Rock holiday.

Our holiday house is greatly enjoyed by many families. To ensure the house remains a beautiful and well-kept holiday destination, we are very strict on our rules and terms and conditions. Failure to respect these rules could result in POSSIBLE EVICTION AND THE DEPOSIT NOT BEING RETURNED.
